1) EWT FILES INDICATE NO ACTIVITY IN CONNECTION WITH SUBJECT CASE SINCE TRANSMISSION ON MARCH 5, 1973, OF REF C SUGGESTING (A) CERTAIN PROVISIONS WHICH SHOULD BE INCLUDED IN THE CONTRACT IN ORDER TO SUPPLEMENT THE GENERAL ASSURANCE PREVIOUSLY RECEIVED BY THE FRENCH FROM THE CHINESE GOVERNMENT AND REPORTED IN REF B AND (B) THAT THE FRENCH GOVERNMENT UNDERTAKE TO ADVISE COCOM OF THE LOCATION OF THE EQUIPMENT AS SOON AS KNOWN. IF THIS SOLUTION WAS UNACCEPTABLE TO THE FRENCH, USDEL WAS TO OBJECT.
