SUBJECT: CIVAIR - FARE PROBLEM

- 1. ASSISTANT SECRETARY BINDER (DOT) DISCUSSED WITH STONER (MOT) MAY 6 OUR CONCERN ABOUT THE DEADLOCK IN SECURING IATA AGREEMENT ON ADDITIONAL FIVE PERCENT FUEL SURCHARGE TO BE EFFECTIVE AT THE END OF THIS MONTH. INITIALLY, NATIONAL AIRLINES AND AIR CANADA WERE AGAINST THE INCREASE BUT BINDER WAS CONFIDENT THAT NATIONAL WOULD WITHDRAW ITS OBJECTIONS (WHICH IN FACT IT HAS NOW DONE). STONER ADMITTED THAT HE HAD NOT SEEN ANY FACTS TO DOCUMENT AIR CANADA'S "GUT" FEELING THAT THE INCREASE IN REVENUE RESULTING FROM THE FARE HIKE WOULD BE NEGATED BY A DECREASE IN TRAFFIC. BINDER THEN SUGGESTED TRYING TO BREAK THE DEADLOCK BY BRINGING THE CARRIERS TOGETHER (TWA, PAA AND AC) IN THE PRESENCE OF REPRESENTATIVES OF MOT AND DOT (ALSO POSSIBLY STATE AND CAB). STONER REACTED FAVORABLY IN PRINCIPLE BUT WISHED TO CONSULT HIS COLLEAGUES AND AIR CANADA.
