1. REFTELS TRANSMITTED EMBASSY SUMMARIES OF CLASSIFIED MEMORANDA PROVIDED TO US AT THE KING'S DIRECTION. THE MEMORANDA THEMSELVES WERE POUCHED JULY 14 TO EUR/WE - HUGHES FOR APPROPRIATE DISTRIBUTION.

2. WHILE OUR IMPRESSION HERE IS THAT THE LINE TAKEN BY THE CHINESE WAS ESSENTIALLY THEIR NORMAL ONE, WE WOULD APPRECIATE WASHINGTON'S VIEWS AND REACTIONS FOR POSSIBLE USE IN COMMENTING TO THE KING. THE AMBASSADOR WILL BE SEEING THE KING FOR PRESENTATION OF CREDENTIALS ON JULY 20. IT WOULD THUS BE USEFUL TO HAVE WASHINGTON COMMENT BEFORE THEN. TODMAN
