1. AS DEPT AWARE (REFTEL B), FLYING TIGERS HAVE BEEN
TRANSPPNTING UNIFORMS AND WEBBING FROM SOUTH KOREA TO ADDIS
FOR MILITIA AND ARMY. THERE HAS BEEN NO EFFORT TO HIDE
ARRIVAL OF AIRCRAFT AT BOLE AIRPORT IN ADDIS, AND WHILE ROK
HAS MADE NO ANNOUNCEMENT THAT WE AWARE OF, FACT THAT SOUTH
KOREA IS SUPPLYING EPMG WITH UNIFORMS IS OPEN SECRET HERE
(SEVERAL PRESS ACCOUNTS OF JUNE MILITIA PARADE ERRONEOUSLY
IDENTIFIED NORTH KOREA AS SOURCE OF UNIFORMS), AND NO DOUBT
KNOWN TO SOMALI EMBASSY. WE HAVE NO EVIDENCE THAT
AIRCRAFT ARE CARRYING ANYTHING ELSE.
