SUBJECT: HIROSHIMA RE-ENACTMENT

1. 1ST NORTH AMERICA DIVDIR WATANABE INFORMED EMBOFF SEPT 20 THAT FONOFF HAD RECEIVED LETTER FROM MAYOR OF HIROSHIMA EXPRESSING "MOUNTING CONCERN" THERE THAT CONFEDERATE AIR FORCE PLANNED TO STAGE ANOTHER RE-ENACTMENT OF HIROSHIMA BOMBING. HE STRESSED SERIOUSNESS WITH WHICH FONOFF VIEWED THAT POSSIBILITY AND SAID JAPANESE EMBASSY WASHINGTON WOULD BE INSTRUCTED TO CONVEY GOJ CONCERN TO DEPARTMENT.

2. EMBOFF ASSURED WATANABE THAT DEPARTMENT WAS FULLY AWARE OF SENSITIVITY AND SERIOUSNESS OF MATTER AND SHARED FONOFF CONCERN. HE NOTED DEPARTMENT OFFICERS HAD PLANNED TO MEET CAF LEADERS IN ATTEMPT TO CONVINCING THEM NOT TO GO AHEAD WITH RE-ANACTMENT (REFTEL) AND THAT WE WERE AWAITING REPORT ON OUTCOME OF THAT MEETING. WATANABE ASKED THAT HE BE INFORMED AS SOON AS POSSIBLE.

3. WOULD APPRECIATE LATEST INFORMATION AVAILABLE ON CAF PLANS.
