1. EMBASSY RECEIVED FEB. 1 COPY OF TELEX SENT IN FRENCH TO NTSB BY ACCIDENT INVESTIGATION BUREAU, DGAC. EMBASSY WAS ONLY APPRISED OF ACCIDENT JAN. 31 WHEN DGAC ASKED FAA HELP IN SECURING INFO CONTAINED IN PARA. 4 BELOW. WE HAD SEEN NO MENTION OF ACCIDENT IN THE PRESS AND WE EXPRESSED SURPRISE DGAC WAS INFORMING EMBASSY, AND NTSB, OF ACCIDENT ONLY AT THIS LATE DATE.

2. INFO CONTAINED DGAC TELEX TO NTSB IS AS FOLLOWS:
FATAL ACCIDENT INVOLVED PIPER COMMANCHE PA-24 BEAURING US REGISTRY N 8184P ON DEC. 31, 1976 AT 10.32 AM IN OPEN AREA NEAR TOWNS OF ORMES AND EVREUX, DEPARTMENT OF EURE WEST OF PARIS. AIRCRAFT ENROUTE FROM TOUSSUS-LE-NOBLE (G.A. AIRPORT NEAR PARIS) TO ISLE OF JERSEY. AMERICAN

PILOT HAROLD HILL AND 3 FRENCH PASSENGERS KILLED. AIRCRAFT TOTAL WRECK. APPARENTLY STRUCTURAL FAILURE OCCURRED IN IFR FLIGHT CONDITIONS. FRENCH AUTHORITIES CONDUCTING INVESTIGATION.

3. DGAC INVESTIGATOR ALSO TOLD US THERE WAS HEAVY TURBULENCE IN AREA AT THE TIME OF THE ACCIDENT.

4. EMBASSY RECORDS SHOW RECEIPT DGAC NOTIFICATION
DATED MAY 9, 1974 INDICATING HAROLD HILL WAS SUSPENDED
FROM FLYING ONE YEAR IN FRANCE FOR VIOLATING FRENCH RULES
WE ALSO FIND NO RECORD OF REGISTRY ABOVE AIRCRFT IN
LAST TWO ISSUES OF CIVIL AIRCRAFT REGISTERS. HOWEVER,
DGAC REQUIRES FOR INSURANCE PURPOSES INDICATION OF DATE
AND VALIDITY OF AIRWORTHINESS CERTIFICATE FOR AIRCRAFT
OF ABOVE REGISTRY. EMBASSY WOULD BE GRATEFUL IF FAA
OKLAHOMA CITY COULD HELP CLARIFY SITUATION. PLEASE SEND
REPLY TO APAR-1.
