PR HAS BEEN DISCUSSED IN THE COMMITTEE OF 24 AND WILL BE AGAIN AT THE COMMITTEE'S NEXT SESSIN IN EARLY 1976.

2. AN ATTEMPT WAS MADE BY CUBA TO INCLUDE AN ITEM DEALING WITH PR IN THE AGENDA OF THE GA IN 1971 BUT WAS REJECTED BY THE GENERAL COMMITTEE AND THE GA. THERE HAS BEEN NO ATTEMPT SINCE 1971 TO INSCRIBE A PUERTO RICAN ITEM.
