1. THE NEW (NON-RESIDENT) IRISH AMBASSADOR TO POLAND, MISS MARY CATHERINE TINNEY, IS THE ONLY WOMAN IN A SENIOR POST IN THE IRISH FOREIGN SERVICE. SHE WAS BORN (1924) IN SCOTLAND, EDUCATED AT UNIVERSITY COLLEGE, DUBLIN (B.A. WITH HONORS), AND ENTERED THE FOREIGN SERVICE IN 1948. SHE SERVED IN STOCKHOLM, LONDON AND IN VARIOUS DUBLIN ASSIGNMENTS PRIOR TO BEING APPOINTED AMBASSADOR TO SWEDEN AND FINLAND IN NOV, 1973.

2. OUR POLITICAL OFFICER KNEW AMBASSADOR TINNEY SLIGHTLY IN STOCKHOLM AND DESCRIBES HER AS A CHARMING, INTELLIGENT, SHREWD AND VERY PROFESSIONAL DIPLOMAT. PERHAPS EMBASSY STOCKHOLM COULD PROVIDE FURTHER INFORMATION. CURLEY
